# 1. About this TOOLKIT

The aim of this Biodiversa+ communication toolkit is to help our partners communicate about the European Biodiversity Partnership and provide them with a summary of the best practices to outline Biodiversa+'s identity, through a variety of concrete examples.

The elements presented in this toolkit can directly be used by our partners on their websites and external communication outlets or can serve as an inspiration for their own external communication.

# 2. Biodiversa+ summaries

# 2.1. Short summary

Biodiversa+ is the European Biodiversity Partnership supporting excellent research on biodiversity with impact for society and policy, and promoting the harmonisation of biodiversity monitoring schemes across Europe. It builds on the legacy of BiodivERsA, and was co-developed with the European Commission as part of the European Biodiversity Strategy for 2030. Biodiversa+ gathers 74 research and environmental policy actors from 37 countries, mobilising a budget of >800 Mio € over 7 years.

# 2.2. Longer summary

Biodiversa+ is the European Biodiversity Partnership supporting excellent research on biodiversity with impact on society and policy, and promoting the harmonisation of biodiversity monitoring schemes across Europe. Biodiversa+ is co-funded by the European Commission (DG Research & Innovation and DG Environment) and was officially launched on 1 October 2021, building on over 15 years of legacy from BiodivERsA. It is part of the European Biodiversity Strategy for 2030 that aims to put Europe's biodiversity on a path to recovery by 2030. Promoting transformative change, the Partnership seeks to link science, policy, and practice. It gathers 74 research programmers, funders and environmental policy actors from 37 European and associated countries to work on 5 main objectives based on

the support and promotion of biodiversity research and innovation through its annual call for transnational research projects, the set-up of harmonized biodiversity monitoring schemes in Europe, Nature-based Solutions deployment and making the business case for biodiversity, brokerage and transfer of science-based knowledge to policy, and the internationalisation of European research and innovation.

Biodiversa+ priorities and activities are detailed in the <u>Biodiversa+ Strategic Research and</u> <u>Innovation Agenda (SRIA)</u>. Its themes are closely related to the <u>EU Biodiversity Strategy for</u> <u>2030</u>, innovative in science, action-oriented (impact on society and policy), and able to foster synergies between various sectors, actors, and policies. They also complement other aspects of Horizon Europe and contribute to the EU's long-term strategic research and innovation agenda.

Biodiversa+ encourages closer cooperation between national/local and European policy makers in charge of biodiversity and associated concerns through its membership and governance. It also offers a comprehensive platform that fosters effective communication and exchange between concerned parties (scientific community, public authorities, businesses, citizens, societal actors, NGOs etc.)

- 1. Plan and support research and innovation on biodiversity through a shared strategy, annual joint calls for research projects and capacity building activities;
- 2. Set up a network of harmonised schemes to improve monitoring of biodiversity and ecosystem services across Europe;
- Contribute to high-end knowledge for deploying Nature-based Solutions and valuation of biodiversity in the private sector;



- 4. Ensure efficient science-based support for policy-making and implementation in Europe;
- 5. Strengthen the relevance and impact of pan-European research on biodiversity in a global context.


