




Registered Biodiversa+ partners per type of organisation

## Reminders about Biodiversa+


### What is Biodiversa+?

- The European Biodiversity Partnership: a Horizon Europe project
- Launched on the 1st of October 2021 and currently ending in September 2028



### How to be involved in Biodiversa+?





As a Biodiversa+ **Partner** (full member of the consortium, signing the Grant Agreement and Consortium Agreement), with a vote in the General Assembly, organisation receiving EC payment.

⚠ A Biodiversa+ Partner cannot be a research performing organisation.

As an **affiliated entity** (an organisation with a formal link with the beneficiary. They do not sign the Grant Agreement but are listed in the Grant Agreement in article 8 and they sign the Consortium Agreement.

▲ An affiliated entity cannot be a research performing organisation.

As **third party** (an organisation, no formal link with the Biodiversa+ Partner needed). They do not sign the Grant Agreement but are listed in the Grant Agreement in annexes I and II.

A Representatives of a Biodiversa+ partner, based in a third party organisation cannot apply in Biodiversa+ research calls.



## What is a third party giving in-kind contribution to Biodiversa+?



- ✓ An organisation valorising Horizon Europe eligible costs for the implementation of Biodiversa+ activities through a Biodiversa+ partner.
- ✓ There is **no need for** your organisation to have **a formal link** between this third party organisation and the Biodiversa+ partner.
- ✓ A third party organisation is not signing the Grant Agreement and not signing the Consortium Agreement BUT is listed in Annexes I and II of the Grant Agreement. >> If your third parties are not listed yet in the Grant Agreement → please let the OT know.

Pay attention not to confuse: A "third party giving in-kind contribution to Biodiversa+" and the cost category "financial support to third parties". The latter is a cost category to report on research call fundings by research organisations whereas the former is a level of participation in Biodiversa+.



What is a third party giving in-kind contribution to Biodiversa+? | Some useful resources.



In Biodiversa+, our **Grant Agreement**, the rules for the third parties giving in kind contribution to the action are in **article 9.2**.

Our Grant Agreement states that « third parties may give in-kind contributions to the action if necessary for the implementation »

### Valorising costs in Biodiversa+



- When incurring costs for Biodiversa+ (or to be valorised in Biodiversa+) it is
  the responsibility of each Partner to ensure the eligibility of costs based
  on our Grant Agreement article 6 and Horizon Europe rules.
- Biodiversa+ Partners must inform their affiliated entities and third parties.
- The Operational Team is always happy to support / guide you but this is your responsibility to ensure the eligibility.
- More information is available in the annotated Grant Agreement for Horizon Europe and you can reach out to your national contact points for Horizon Europe.







## Reporting on costs and involvement in activities

### Reporting exercises | Some reminders

For the EC, Biodiversa+ has to report on:

- Our progresses on the Biodiversa+ activities (through our periodic reports). Exercise led by the Chairs Team,
   Operational Team, WP and task leaders
- The use of the budget (all the Biodiversa+ partners must report on this part)

Internal reporting exercises allow Biodiversa+ to monitor the use of our budget and properly plan future payment to partners. This is equally important as EC financial reporting. All the partners must contribute to this effort.

- ▼ The Biodiversa+ partners should coordinate their reporting exercise and compile information from their third parties giving in-kind contribution to the action and from their affiliated entities.
- ✓ All costs included in reporting exercises must be eligible to EC funding.
- ✓ We have to report on the use of the budget for each cost category, by each partner, for each task/subtask.
- The Biodiversa+ partner should ensure that an **audit** can take place to check its own costs (in your organisation) or in the organisations of your third parties giving in-kind contribution to the action or affiliated entities. All costs included in the reporting exercises must be verifiable.

**B. SUBCONTRACTING COSTS** 

⚠ Biodiversa+ will never check your time sheets / invoices. However, when reporting on your costs you have to ensure that you are reporting on your actual costs in case of an audit in the years to come.

## Involvement of third parties giving in-kind contribution to the action → Where?




#### In WP2 activities

- ✓ To lead a Biodiversa+ task or pilot (on biodiversity monitoring) on behalf your organisation (WP2 task).
- ✓ To be an active contributor in a pilot on your behalf (task 2.6)
- ✓ To follow the Biodiversa+ bidiversity monitoring activities on your behalf (for example attend annual workshops with all partners in task 2.5)

### At national level/ for your EC top-up:

- ✓ To valorise national biodiversity monitoring costs on the Biodiversa+ priorities (task 2.5 WP2-nat)
- ✓ To spend your EC top-up to reinforce your national biodiversity monitoring schemes or to create new ones on the Biodiversa+ priorities (task 2.5 WP2-nat)





## Involvement of third parties giving in-kind contribution to the action → How?



WP2 Activities

National level / EC top-up

At the start of an activity (for example: 2<sup>nd</sup> installment preparation) send the names of your third party organisations to the Biodiversa+ operational team so that they can be added in the Grant Agreement

Ensure a smooth communication with your third parties and inform them about Horizon Europe rules.

Share their contact details with the operational team, if relevant.



It is **strongly recommended** to sign an agreement between the third party and Biodiversa+ Partner.



## Recap of the roles of a Biodiversa+ partner and third parties giving in-kind contribution to the action



### Role of a Biodiversa+ partner:

- Ensure that your third parties are properly identified in the Grant Agreement
- Ensure that your third parties are aware of Horizon Europe rules
- Ensure that your third party can be audited
- Transfer the information from Biodiversa+ to the third party (main contact point for Biodiversa+)
- Transfer the budget from Biodiversa+ to your third parties (if relevant)


### Role of a third party:

- Implement the activities on behalf the Biodiversa+ partner (pay attention to your conflict of interests)
- Keep track of your time and other expenses you may have

## Ministry of the Environment, Finland & Finnish Environment Institute

- MoE FI (Biodiversa+ Partner)
  - Results-based management and supervision of the Finnish Environment Institute
- Finnish Environment Institute (Biodiversa+ Third Party)
  - Independent environmental research and development centre, about 700 employers, annual budget of 70 M€
- Both are accounting offices of the Finnish state, but independent
  - eligible third party costs = seconded personnel costs, also for in-kind contribution
  - MoE FI acquisitions from the Finnish Environment Institute: decision on procurement according to the national Act on Public Procurement + conditions according to the secondment concept note = secondment agreement
  - Compulsory employee time tracking & PM calculation according to the HE funding rules > must be ensured for reporting, but "safer" option than purchase costs
  - Financial reporting will be based on actual costs incurred > don't overestimate when valorizing in-kind contribution. Ask your financial planning officer for help before valorizing in-kind contribution
  - to be kept in mind: information on a person's (annual) salary is sensitive according to the GDPR
